#### 1. Why are we consulting?

- We are seeking feedback from NAIT Scheme participants on how the implementation of the NAIT Scheme can be improved.
- NAIT Ltd and its funders review the NAIT Scheme every three years.
   Key aspects of the review include:
  - Developing a three-year strategy for implementing the NAIT Scheme.
  - Calculating funding to deliver the strategy, including levy adjustments (if necessary).
- Consultation feedback will be used to inform the development of the 2025-2028 Traceability Operational Strategy.

#### Who are we consulting?

The success of NAIT Scheme relies on collaborative effort of everyone who uses and implements it.

NAIT Ltd is seeking the views of NAIT Scheme participants to better understand how implementation of the scheme can be improved. This includes views from:

- Farmers, PICAs (Person In Charge of Animals), and PICA delegates.
- Saleyards.
- Stock and station agents.
- Meat processors.
- Livestock exporters.
- Livestock transport operators.
- Tag manufacturers.
- Information providers and accredited entities.



#### 2. Why the NAIT Scheme matters

Animal traceability is critical to the success of New Zealand's beef, dairy, and deer industries. Animal identification and traceability information helps protect farmers livelihoods by:

- Enabling effective responses to livestock disease outbreaks;
- Supporting food-safety assurances of livestock products; and
- Supporting market assurance and access for livestock products.

The NAIT Scheme's ability to protect the deer and cattle industry is critically dependent upon PICAs and Accredited Entities that are willing and able to meet their NAIT obligations.

## 3. NAIT Scheme objectives and outcomes

The NAIT Scheme has the below objectives and outcomes:

#### **Objective 1: Farmers and PICAs are contactable**

**Outcome 1:** In the event of a biosecurity outbreak or other civil emergency, affected farmers can easily and quickly be identified and contacted.

#### **Objective 2: NAIT locations are known**

**Outcome 2:** Farms that may be at risk of a biosecurity or food safety event can be quickly identified.

#### **Objective 3: NAIT animals are identified**

**Outcome 3:** Animals that may be at risk from a biosecurity or food safety event can be quickly identified.

#### **Objective 4: NAIT animal movements are known**

**Outcome 4:** Animals that may be at risk from a biosecurity or food safety event can be quickly identified and located.



# 4. How does the NAIT Scheme achieve its objectives and outcomes?

#### **PICA obligations**

It specifies PICAs legal obligations for ensuring that accurate and up-to-date traceability information is available. Their obligations are to:



#### **NAIT Ltd's obligations**

It specifies NAIT Ltd's legal obligations and powers to implement the NAIT Scheme. Our obligations are to:

- 1. Issue, maintain and administer standards that:
  - Ensure NAIT identification devices (ear tags) provide unique, clear and lasting identification.
  - Ensure accredited information providers and entities dealing in NAIT animals (e.g. saleyards, meat processors) who carry one 1 or more functions on behalf of a PICA can carry out these functions in a manner that also protects personal privacy and data security.
- 2. Provide the NAIT Information System to enable participants to meet their obligations.
- 3. Provide information to support biosecurity, food safety and market access purposes.
- 4. Provide information, educational material and training to scheme participants.
- 5. Monitor participant compliance with their obligations.
- 6. Undertake compliance and enforcement (in collaboration with MPI).




#### The VADE model

NAIT Ltd uses the VADE model to implement the NAIT scheme. This model acknowledges that PICAs differ in their willingness and ability to meet legal requirements and guides us on the type of assistance and intervention required. The most effective regulatory approach depends on each PICA's attitude and behaviour towards compliance, as described in the diagram below.

When the VADE model is successfully applied, the number of PICAs at the top of the pyramid decreases over time. As a result, more PICAs move into the Voluntary section, while fewer remain in the Directed and Enforced sections.

  - NAIT tags.
  - Accredited information providers saleyards and meat processors.
- NAIT Information System.
- Information, education, training:
  - Website.
  - Communications campaigns.
  - Regional workshops / training.
  - Fieldays.

PICAs willing to comply, but lacking awareness or capability


#### **Assist PICAs to comply**


